Executive Secretary, Stefan Ritter gave the following presentations:

- Report on Case Backlog:

This year to date, we have 8 new cases, of which five (5) were received since the last meeting. As of today, over 160 backlogged cases are closed, with the exception of those in collections. This brings our total up to 100% of those cases which have been closed.

• Update on Collections Cases:

Of the fifty-four (54) cases at the Department of Law – Collections Division, we have managed to get it down to sixteen (16) open cases. Ten (10) cases are in active repayment and six (6) cases are still being acted on.

Office Space Update:

Construction has been completed and we are now in the process of arranging the files and resolving furniture issues. An open house is anticipated when the furniture issues are resolved.

• Department of Audits – Follow-up Audit:

The Department of Audits will be doing a follow-up audit in August or September to the Audit that was done October 15, 2014. We feel confident that we have addressed and continue to address the issues brought forth in that audit.

Employee Update:

We look to hire three (3) new employees in the near future. The Governor approved a 2% increase for salaries and pensions based on merit. Our budget appears to be stable and not suspected to go down. We have underspent for two years now, giving back approximately \$300,000 to the State, since we were unable to hire due to space issues in the past.

#### **ATTORNEY GENERAL'S COMMENTS:**

Christian Fuller gave an update on the pending cases in their office, including those that are in various stages of sending to Office of State Administrative Hearings (OSAH).
